WORKPLACE SAFETY COMMITTEE CAN SAVE YOU MONEY

Would you like to reduce your workers' compensation premiums by 5 percent each year? Employers throughout Pennsylvania have already saved millions in insurance premiums by setting up a workplace safety committee that meets the requirements for state certification. The certification requirements include (1) Committees must contain a minimum of two employers and two employees, meet monthly and be in operation for at least six months; (2) All committee members must be trained by qualified trainers in safety committee operation, hazard inspection and accident investigation; and, (3) Committee meeting agenda, attendance lists and meeting minutes must be kept. **To apply for certification**, you will need to complete a committee certification application and have it approved by the Department of Labor and Industry. LINK TO REQUIRED WORKPLACE POSTERS NOW AVAILABLE ON PARTS WEB SITE

As an employer in Pennsylvania, you are required to post certain notices at your worksite so your employees have access to and information about applicable labor laws. These posters must be hung in a location where they are easily accessible to all your employees. Failure to post these signs can result in fines.
